Explanatory note (EN)

Instructions to draw up the accompanying document for the transport of wine products aimed to article 24(1)(a) (iii) of Regulation (EC) n° 436/2009 of the Commission of May 26th, 2009

1d	Reference number: each consignment must bear a reference number which identifies it in the consignor's accounts. This number is the MVV code assigned to the accompanying document in its administrative or commercial form, under the conditions laid down by the Member State: <i>see article 24 of Regulation (EC) n°436/2009.</i>
2	Consignor: full name and address including post code and the excise number (SEED ¹) if the operator is identified in that database.
3	Place of dispatch: the actual place of dispatch, if the goods are not dispatched from the address given for the consignor and where appropriate the excise number (SEED).
5	Consignee: full name and address including post code and the excise number (SEED) if the operator is identified in that database.
7	Place of delivery: the actual place of delivery, if the goods are not delivered to the address given for the consignee and where appropriate the excise number (SEED). Where there is a change in the place of delivery: the actual place of delivery shall be indicated on the back of the document
10	Competent authorities at place of dispatch: the name and address of the competent authority responsible for checking the drawing up of the accompanying document at the place of dispatch. This is only required in the case of dispatch to another Member State or for export outside the Union.
15	Carrier: name and address of the person responsible for organising the first movement (if different from the consignor).
16	Other transport details: (a) the type of transport used (lorry, van, tanker, motor car, railway wagon, rail tanker, aeroplane); (b) the registration number or, in the case of a ship, the name (optional particulars). Where there is a change from one type of transport to another (<i>see box 7 of the e-AD, as provided for in table 3 of Annex 1 to Regulation 684/2009</i>), the carrier loading the product must indicate on the back of the document: - the date of dispatch, - the type of transport used and the registration number for vehicles and the name for ships, - their name, forename or company name and address, including post code, - the actual place of delivery, if the place of delivery is changed.
17.1	Description of packages of goods: identification numbers and number of packages, number of internal packages. For the accompanying documents other than those referred to in Article 24(1)(a)(i), the description may be continued on a separate sheet attached to each copy. A packing list could be used for this purpose.
17c	Code(s) of the combined nomenclature (CN code)
17p, g and o	Description of the product: in accordance with Articles 118y and 118z of Regulation (EC) No 1234/2007 and any national rules which apply, in particular compulsory indications. For bulk transport: - the actual alcoholic strength, for wines - the refractive index or the density, for non-fermented products - the total alcoholic strength, for products in fermentation, - the total alcoholic strength, for wines with a residual sugar content of more than four grams per litre, in addition to the actual alcoholic strength Optional indications for bulk transport: for the bulk transport of the wines referred to in <i>paragraphs 1 to 9, 15 and 16 of Annex XIb to Regulation (EC) No 1234/2007</i> , the product description shall contain the optional particulars set out in <i>Article 118z of that Regulation</i> , provided that they are shown on the labelling or that it is planned to show them on the labelling.
17d, 17e, 17f	Quantity and weight: - for products in bulk, the total net quantity, - for packaged products, the number of containers used.
17.2a	Wine product category: For wine products included in <i>Part XII of Annex I to Regulation (EC) No 1234/2007</i> , provide one of the following values: 1 = Wine without PDO/PGI, 2 = Varietal wine without PDO/PGI, 3 = Wine with PDO or PGI, 4 = Imported wine, 5 = Other
17.2b	Wine zone code: Provide the wine-growing zone in which the product transported originates in accordance with <i>appendix of Annex XIb to Regulation (EC) No 1234/2007</i>
17.2.1a	Wine operation code: Provide one or several 'Wine operation Code(s)' in accordance with <i>list 1.4. b) in point B of Annex VI to Commission Regulation (EC) No 436/2009</i>
17i	Certifications: certification of PDO, certification of PGI or certification of the vintage year or of the wine-grape variety(ies): <i>see Article 24(1)(b) and Article 31.</i>
17.2d	Other information: Complementary elements to those of the box 17i or information related to the quality of the products, the analyses carried out or labelling, in particular that of the substances potentially allergens when this one is necessary in the Member State or the third country of destination,...

9 ^e - 9 ^f	Date of dispatch and, where so laid down by the Member State on whose territory the transport operation begins, the time of dispatch.
